

Clinical Librarian Service (CLS)

The CLS serves all Evidence Centre initiatives by facilitating evidence integration at the point of care through supported clinical and health services question development, search strategy assistance, record and full

Knowledge Brokering (KB) Initiative

Knowledge brokers (KB) are capacity builders, information managers and linking agents that facilitate EIHC. This initiative advances the practice of knowledge brokering through partnerships to support role,

Rapid Response Evidence Service (RRES)

Facilitating evidence informed decision-making for clinical practice or health services delivery, the RRES assists leaders in quickly accessing and implementing evidence in



response to the strategic objectives of the organization, program or team. A spectrum of knowledge products, from reference lists to evidence syntheses and clinical or decision-support tools are generated as a means of supporting implementation.
